The Warranty for Crash-Rated Bollards applies to all crash-rated bollard products. The Warranty for Crash-Rated Bollards does not apply to the rest of the Company's Bollards and Bike Parking products, wheels, or custom castings. Warranties are subject to change without notice. Actual product warranties are provided at time of purchase.

The R-1009-40(-R) C40 Traffic Impact Bollard, Model TIB-67-SA, passed an independent, non-certified ASTM test of a 2432 lbs. vehicle traveling at 42.5 mph, which resulted in less than 24 inches of penetration.

The R-1009-04(-R) ASTM K4 Set & Pour Crash Bollard is tested and certified with ASTM F2656-07 M30 P1 rating.

The R-1009-12(-R) ASTM K12 Set & Pour Crash Bollard is tested and certified with ASTM F2656-07 M50 rating.

The actual performance of the Bollard is dependent on its proper installation, in accordance with its installation specifications, and maintenance of the Bollard's condition and installation bed, including against rust, prior impact, road salt and/or other materials affecting the Bollard and/or its installation bed. The Bollard and the installation bed of the Bollard should be inspected in regular intervals to assure their integrity and condition such that they match their original condition upon installation in accordance with the installation specifications.
